WOOD END PRIMARY SCHOOL The Pupil Premium

The Pupil Premium was introduced to support schools to ensure that children who are disadvantaged are supported so that they reach their full academic potential in school. We aim to identify barriers to learning and remove them. We use approaches that are well researched in terms of being effective in increasing attainment. We use the work of the Education Endowment Fund to support us in identifying key interventions that are proven to be successful. We have reviewed our Pupil Premium Strategy working with an external system leader to ensure we have a clear focus on improving educational outcomes for our most vulnerable pupils.

Our Principles and Objectives

The core aims of our strategy are as follows:

- All Pupil Premium children are provided with quality first teaching
- Interventions that we use are well-founded in research and are proven to raise standards and narrow the gap
- All vulnerable pupils have a named adult to provide support and guidance to them whilst in school "A Friend in the Trade"
- Finance is carefully targeted on a needs basis with clear aims and success criteria in order that we can monitor academic progress
- On a half-termly basis the progress of our Pupil Premium children is tracked and interventions are recorded and evidenced on a provision map.
- We will provide attainment information to our Local Governing Body on a half-termly basis to ensure progress of Pupil Premium children is carefully monitored
- We will use financial support to ensure our Pupil Premium children have full access to a vibrant curriculum
- We will promote good attendance with Pupil Premium children and work closely with our families and outside agencies to ensure poor attendance is tackled robustly
